SEAMAN'S DISCHARGE BOOK





- This Discharge Book is your property and its loss may cause you difficulty in verifying your sea service.
- 2. Your Discharge Book must, on demand, be produced to a Superintendent, a proper officer, the Registra General of Shipping and Seamen, an official of the Merchant Navy Establishment Administration, your employer or to the master of a United Kingdom registered ship in which you are employed.
- If you have handed your Discharge Book to your employer or the master for safe custody and it is not returned to you on your leaving the ship, you should notify the Registry of Shipping and Seamen, Cardiff or a Marine Office.
- 4. Should this Discharge Book be lost, destroyed or defaced, you are required, if you are continuing in sea-going employment, to apply to the Registry of Shipping and Seamen, Cardiff or a Marine Office for a new Discharge Book. A fee may be payable.
- When there is no space for further entries in any section of this Discharge Book, you should apply for a new book.
- NOTE Any person other than the person to whom this Discharge Book was issued who comes into possession of it should deliver it to a Marine Office or send it to the Registry of Shipping and Seamen, P.O. Box 165, Cardiff, CF4 5FU, postage unpaid.

The holder must not make any entry or alteration in this Discharge Book, except to his personal details on page three. If any entry requires alteration the holder of this Discharge Book should apply to the Registry of Shipping




